#### "Keep the Ordinances, As I Delivered Them"

	The Corinthian saints had some serious dysfunctions, but Paul's solution is
Hook	simple—love each other and the rest will work itself out.
Manual Goal	To help class members learn from Paul's teachings about how to
	share the gospel and how to live as Saints.
	To inspire class members to seek charity, that love that cares about another's
	well-being more than one's own self-interest.

# Sunday School

- a. And you think your ward has problems (issues in the Corinthian community: divisiveness, lack of unity, grasping for status; sexual immorality; members taking each other to court; confusion over marriage and sex; debate over food sacrificed to idols; distrust of Paul's authority; women's head coverings [following cultural norms]; the wealthy eating up all the food at the linger longer; unworthiness taking the sacrament; status seeking relating to spiritual gifts; doctrinal misunderstanding [resurrection])
- b. Review the Reading
- c. Learning from Paul's teaching about food sacrificed to diols (1 Cor 8)
- d. Men and women (talk about 1 Cor 11, veils, cultural norms). How do we distinguish cultural norms from gospel principles? (VERY important topic)
- e. Men, women, and the temple
- f. Charity (Discuss each trait one by one) Agapé (that's three syllables tyvm).

  Patient. Kind. Not envious/boastful/rude. Does not insist on its own way. Not resentful/irritable. Rejoices in truth, not wrongdoing. Bears all things, believes all things, endures all things. Never ends.

- a. What did Paul mean by "ordinances"?
- b. Paul's letters in context (occasional, like hearing one side of a phone conversation)
- c. (Remind listeners of the overview of Paul's relationship with the Corinthians last lesson)

- a. But... these scriptures aren't talking about priesthood ordinances (Talk about how often this is done—a verse out of context, applied to distinctive Mormon ideas, in a way that often doesn't hold up upon closer examination. "Celestial" and "Terrestrial" is another example)
- b. Priesthood ordinances down the Rabbit Hole
  - i. Literal belief: How exactly do they save us?
  - ii. Ordinances save us, but not in the way we think
  - iii. Ordinances have value, even if they don't literally save us
- c. Men, Women, and the Temple II (veils)
- d. Spiritual gifts then and now
- e. Nature of the resurrection
- f. Conclusion II
